# Taiwan automobile market status



Benefited from the robust export demand driven by the global economic recovery, manufacturers are optimistic about the future market prospect. In addition, with favorable factors including the increase of domestic investment, returning of Taiwanese businessmen from overseas, and the investment expansion in semiconductor industry, the economy is expected to continue to grow steadily.

Cumulative TIV (total industrial volume) from January to April were 155,024 units, a year-over-year increase of 18.5%. However, considering the uncertainty of the COVID-19 epidemic, the annual TIV is still conservatively estimated at 427,000 units (excluding heavy vehicles).



## P.R.C. automobile market status



### **Dongfeng Nissan Passenger Vehicle Company – Sales performance**



Contributed by the relatively low base period and strong government policy supports, the economic growth of mainland China is expected to rebound significantly in 2021. However, the following risks still need to be carefully assessed, including the uncertainty of COVID-19 epidemic trend, the restoring of investment capacity and confidence level of mainland Chinese companies, and other economic downside risks such as US-China trade and technological disputes. According to the forecast announced by China Association of Automobile Manufacturers, the annual TIV of 2021 is expected to reach 26.3 million units, an increase of 4% on a year-over-year basis.
